Aimee has had a lifelong love of animals.

She had a mixed breed dog in the mid 1980s that was trained through much of utility long before mixed breeds were eligible to compete and even before Aimee knew what utility was.

In 1998 she purchased an Australian Shepherd, Eli, for \$375. Money well spent. Aimee took him for training at the local AKC obedience club so that she could have a nice dog with whom to live. He did very well and her instructor told her she should show him in obedience trials. The instructor helped fill out the entry form and the team came home with two green ribbons and two blue ribbons...the first two legs of their CD. She was

hooked. Eli went from Novice A to UD and sired a couple of litters.

Her husband, Ken Kincaid, purchased a puppy from one of those litters (yes, he was her husband at the time and yes, he purchased the puppy for full price...his decision) and he took the same road, becoming hooked on the sport of obedience also. Several more dogs and lots more titles resulted in a desire to judge. With the encouragement of a good friend, Deb Neufeld, Aimee started on the path to become an AKC Obedience and Rally judge. Her husband joined her on this journey. Her first assignment was August 8, 2010.

Aimee and Ken live in Orlando Florida and own a dog training facility. They train, show, and breed Danish-Swedish Farmdogs. Aimee is looking forward to the joy the exhibitors will feel, and wishes everyone a great week with their best Bernese Mountain Dog friend.

## MR. KENNETH KINCAID



Ken Kincaid is president and CEO of Kincaid Performance Solutions, LLC. Ken's first career was that of firefighter and fire officer. He spent twenty-five years serving the citizens of Florida retiring as an Assistant Chief.

Ken has trained dogs in obedience for many years and has been showing in AKC Obedience since 2005. His first obedience dog, OTCH Boomerang's Copperhead Jake UDX OM2 RE took Ken from Novice A to OTCH and the National Obedience Invitational in Long Beach, CA and Orlando, FL. Jake also had an OTCH3 in the Australian Shepherd Club of America. Ken continues to show acquiring titles on other dogs. His current dog (Captain) received his CD in three trials including a High in Trial and a run-off for High in Trial.

Ken and his wife Aimee have been raising and showing dogs for many years and have shown Australian Shepherds, a Toy Fox Terrier and a Danish-Swedish Farmdog in Obedience.

Ken has been judging since 2010 and has judged for AKC since 2012. Ken tells us, "I love judging because it's so much fun. Watching handlers meet their goals with their dogs is awesome. I like to think I'm at least a small part of that process. I also enjoy the people I meet. Dog people are great to be around, and I get to see great folks and great dogs all over the country."

He is the producer of the You Tube Channel AKC Obedience Exercises Explained. A free video series that details how each obedience exercise is to be performed and explains the regulations affecting each one.

His judging philosophy encompasses fairness, consistency and handler friendliness. Ken tries to constantly hone his craft as a judge to improve those elements. He's had the great pleasure of being judged by many great judges and Ken looks to those individuals as well as AKC judges' education and the regulations to continually mold his judging persona.

Ken says, "AKC Obedience is a wonderful sport and we follow in the footsteps of outstanding handlers, judges and officials. I recognize that every picture that is taken with a handler becomes part of their personal history and that of AKC.
