Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the veterinarian, judge, or Trial Committee.
- <u>Entry fees will not be refunded</u> if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Entries must be made on Official AKC Entry Forms or copies and <u>must include the signed</u> <u>Agreement and Rules</u>. <u>Junior Handlers</u> must complete the back of the entry form. Please include only AKC titles on your entries.
- No entry shall be made, and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures.
- Post Dated and Returned checks do not constitute a valid entry fee. <u>There is a \$25 returned check fee</u>.
- <u>Bitches in season</u> will be permitted to run but will be placed at the end of the running order in Tests and in catalog order for Trial classes.
- It is expressly understood that exhibitors alone <u>are responsible for the behavior of their dogs and/or</u> <u>children</u>. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- Exhibitors are responsible for cleaning up after their dogs at show site and all hotel, motel, and campgrounds where they are staying while competing in these trials.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. BMDCA has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- All dogs must be on lead or crated at all times except when in the arena.
- Dogs must wear a simple well-fitting buckle, snap lock, or slip collar (no tags) or may work without a collar at Trial levels.
- Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
